Additional Notes for Donors

If you pay income tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your self assessment tax return or ask HM Revenue and Customs to adjust your tax code.

The details given overleaf will be held securely and only used for the purposes of reclaiming Gift Aid from HMRC and are not disclosed to any Third Party.

The use of Gift Aid by eligible taxpayers enables the Corris Railway Society to increase the value of your donation/subscription by 25%. The Society is able claim this amount from HM Revenue and Customs from the tax you have paid in the relevant tax year at no cost to the donor.

Once you have signed a Gift Aid declaration you will not need to fill in any additional forms.

You will not pay more in tax as a result of using Gift Aid.

A gift Aid declaration remains in force until you tell us otherwise. You will not need to fill in a form each year.

You may make Gift Aid declarations with as many charities as you wish provided the total Gift Aid to be claimed (25% of your donations) does not exceed the amount of tax you pay in the year.
